Yi Zhang (the 'Landlord') applied for an order to terminate the tenancy and evict Karen Alveranga (the 'Tenant') and for an order to have the Tenant pay the rent the Tenant owes because the Tenant failed to meet a condition specified in the order issued by the Board on March 24, 2020 with respect to application TNL-23119-20.

As a result of a Superior Court of Justice order suspending the enforcement of LTB eviction orders during the period from March 19, 2020 to July 31, 2020, the issuance of this Order has been delayed. Any payments made by the Tenant to the Landlord after the application was filed by the Landlord must be deducted from the amount ordered by the Board.

Determinations:

- 1. The order provided that the Landlord could apply to the Board under section 78 of the *Residential Tenancies Act*, 2006 (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant did not meet certain condition(s) specified in the order.
- 2. I find that the Tenant has not met the following conditions specified in the order: The Tenant failed to pay full \$500.00 toward arrears of rent on or before June 30, 2020. Further, the Tenant failed to pay monthly rent for July 2020 on or before July 1, 2020.
- 3. The previous application included a request for an order for the payment of arrears of rent. The resulting order required the Tenant to pay rent or some or all of the arrears of rent. Accordingly, in addition to eviction, the Landlord is entitled to request an order for the payment of arrears of rent and compensation.
- 4. Since the date of the order, the Tenant has failed to pay the full rent that became owing for the period from July 1, 2020.
- 5. The Landlord collected a rent deposit of \$1,350.00 from the Tenant and this deposit is still being held by the Landlord.
- 6. Interest on the rent deposit is owing to the Tenant for the period from September 30, 2010 to September 11, 2020.

It is ordered that:

 The Landlord shall deduct any payments by the Tenant to the Landlord after the application was filed from amount ordered by the Board.

- 2. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before September 22, 2020.
- 3. The Tenant shall pay to the Landlord \$417.11*. This amount represents the rent owing up to September 11, 2020 and the costs related to the application fee for the previous application, less the rent deposit and interest the Landlord owes on the rent deposit.
- 4. The Tenant shall also pay to the Landlord \$49.55 per day for compensation for the use of the unit starting September 12, 2020 to the date the Tenant moves out of the unit.
- 5. If the Tenant does not pay the Landlord the full amount owing* on or before September 22, 2020, the Tenant will start to owe interest. This will be simple interest calculated from September 23, 2020 at 2.00% annually on the balance outstanding.
- 6. If the unit is not vacated on or before September 22, 2020, then starting September 23, 2020, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
- 7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after September 23, 2020.
