James Stephenson (the 'Landlord') applied for an order to terminate the tenancy and evict Charles Russell (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard in Barrie on January 26, 2010.

The Landlord and the Tenant attended the hearing. At the hearing, the parties consented to the $\frac{370.5}{100.5}$ following order.

It is ordered that:

- 1. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before February 10, 2010.
- 2. The Tenant shall pay to the Landlord \$1,000.00, which represents the net amount of rent owing and compensation up to February 10, 2010.
- 3. The Tenant shall also pay to the Landlord \$42.74 per day for compensation for the use of the unit starting February 11, 2010 to the date he moves out of the unit.
- 4. If the Tenant does not pay the Landlord the full amount owing on or before February 10, 2010, the Tenant will start to owe interest. This will be simple interest calculated from February 11, 2010 at 2.00% annually on the balance outstanding.
- 5. If the unit is not vacated on or before February 10, 2010, then starting February 11, 2010, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

6. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord, on or after February 11, 2010.
