Joan Zenia Gonzales and Keron Marc Gonzales (the 'Landlords') applied for an order to terminate the tenancy and evict Carrie Allen and Tiana Allen (the 'Tenants') because the Tenants did not pay the rent that the Tenant owes.

A hearing of this application took place by videoconference on January 31, 2023.

The Landlord Keron Marc Gonzales and the Tenant Carrie Allen attended the hearing.

At the hearing, the parties engaged in mediation. As a result of the resolution discussion, the parties reached a settlement of all issues arising from the tenancy for the period up to the date of the hearing. I was satisfied that the parties understood the terms and consequences of their consent.

It is ordered on consent that:

- 1. The tenancy between the Landlords and the Tenants was terminated in November 2022.
- 2. The Tenants shall pay to the Landlords the sum of \$8,157.00. This amount represents a full and final settlement of all issues arising from the tenancy for the period up to the date of the hearing.
- 3. The Tenants shall pay to the Landlords the amount set out in paragraph 2 in accordance with the following schedule:

The monies owing shall bear interest at the post-judgement interest rate determined under subsection 207(7) of the *Residential Tenancies Act*, 2006.
