



Order under Section 69  
**Residential Tenancies Act, 2006**

Dinesh Ramesh Tenant

Accommod8u Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Dinesh Ramesh (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes. The Landlord also claimed administration charges related to NSF cheques.

This application was heard by videoconference on September 9, 2021.

The Landlord's Legal Representative, Gayle St. Clair attended the hearing. As of 1:42 p.m., the Tenant was not present or represented at the hearing although properly served with notice of this hearing by the Board.

**Determinations:**

1. The Tenant has not paid the total rent the Tenant was required to pay for the period from May 1, 2021 to September 30, 2021. Because of the arrears, the Landlord served a Notice of Termination effective July 9, 2021.
2. The Tenant is in possession of the rental unit.
3. The lawful monthly rent is \$731.00.
4. The Landlord incurred charges of \$60.00 for administration charges related to cheques tendered by or on behalf of the Tenant, which were returned NSF.
5. The Landlord collected a rent deposit of \$694.00 from the Tenant and this deposit is still being held by the Landlord.
6. Interest on the rent deposit is owing to the Tenant for the period from October 14, 2020 to July 9, 2021.

I have considered all of the disclosed circumstances in accordance with subsection 83 of the *Residential Tenancies Act, 2006* (RTA), including the impact of COVID-19 on the parties and whether the Landlord attempted to negotiate a repayment agreement with the Tenant and find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act. The Tenants did not attend the hearing to present evidence or submissions in support of granting relief from eviction and no circumstances were disclosed at the hearing or appeared in the Board file.

**It is ordered that:**

1. Unless the Tenant voids the order as set out below, the tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before November 29, 2021.
2. The Tenant shall pay to the Landlord \$4,215.75\*, which represents the amount of rent owing and compensation up to November 18, 2021 and the total charges related to NSF cheques tendered to the Landlord by or on behalf of the Tenant, less the rent deposit and interest the Landlord owes on the rent deposit.
3. The Tenant shall also pay to the Landlord \$24.03 per day for compensation for the use of the unit starting November 19, 2021 to the date the Tenant moves out of the unit.
4. The Tenant shall also pay to the Landlord \$186.00 for the cost of filing the application.
5. If the Tenant does not pay the Landlord the full amount owing\* on or before November 29, 2021, the Tenant will start to owe interest. This will be simple interest calculated from November 30, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before November 29, 2021, then starting November 30, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord, on or after November 30, 2021.
8. If, on or before November 29, 2021, the Tenant pays the amount of \$5,363.00\*\* to the Landlord or to the Board in trust, this order for eviction will be void. This means that the tenancy would not be terminated, and the Tenant could remain in the unit. If this payment is not made in full and on time, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. The Tenant may make a motion to the Board under subsection 74(11) of the Act to set aside this order if they pay the amount required under that subsection on or after November 30, 2021 but before the Sheriff gives vacant possession to the Landlord. The Tenant is only entitled to make this motion once during the period of the tenancy agreement with the Landlord.
