Tenants

Ali Mahini and Aghdas Mahini (the 'Landlords') applied for an order to terminate the tenancy and evict Johnathan Mamone and Cassandra Terryberry (the 'Tenants') and for an order to have the Tenants pay the rent they owe because the Tenants failed to meet a condition specified in the order issued by the Board on December 16, 2020 with respect to application SOL-15351-20.

The Landlords' application was resolved by order SOL-19175-21, issued on January 28, 2021. The Tenants filed a motion to set aside order SOL-19175-21.

This motion was heard by videoconference on March 10, 2021.

The Landlords and the Tenants attended the hearing.

The parties before the Board consented to the following order:

I am satisfied that the parties understood the consequences of their consent.

On consent, it is ordered that:

- 1. Order SOL-19175-21, issued on January 28, 2021 is set aside and replaced with the following order.
- 2. The arrears and costs owing to March 31, 2021 total \$2,655.00.
- 3. The Tenants shall pay to the Landlords \$2,655.00 as follows:
 - a) \$1,000.00 on or before March 19, 2021;
 - b) \$500.00 on or before April 2, 2021;

- c) \$500.00 on or before May 7, 2021;
- d) \$500.00 on or before June 4, 2021; and
- e) \$155.00 on or before July 2, 2021.
- 4. The Tenants shall also pay to the Landlords the lawful monthly rent as it comes due in full and no later than the first day of each month commencing April 1, 2021 through to July 31, 2021.
- 5. If the Tenants fail to make any one of the payments in accordance with this order, the Landlords may, without notice to the Tenants and within 30 days of the breach, apply to the Board pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenants and requiring that the Tenants pay any new arrears, NSF fees and related charges that became owing after March 31, 2021.
