D.D.C.O. REI Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Owen Wortley, Rogatien Rozon and Shirley Wortley (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on January 16, 2023.

Only the Landlord's Legal Representative C. Lewin and the Landlord's Agent D. Distefano attended the hearing.

As of 1:49 p.m., the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlord's evidence.

Determinations:

- The Landlord served the Tenants with a valid Notice to End Tenancy Early for Nonpayment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
- 2. The Tenants were in possession of the rental unit on the date the application was filed.
- 3. The Tenants vacated the rental unit on June 30, 2022. Rent arrears are calculated up to the date the Tenants vacated the unit.
- 4. The lawful rent is \$2,600.00. It was due on the 1st day of each month.
- 5. The Tenants have not made any payments since the application was filed.
- 6. The rent arrears owing to June 30, 2022 are \$12,179.76.
- 7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

8. The Landlord collected a rent deposit of \$2,600.00 from the Tenants and this deposit is still being held by the Landlord. The rent deposit is applied to the tenancy terminated.

9. Interest on the rent deposit, in the amount of \$19.66 is owing to the Tenants for the period from November 13, 2020 to June 30, 2022.

It is ordered that:

- 1. The tenancy between the Landlord and the Tenants is terminated as of June 30, 2022, the date the Tenants moved out of the rental unit
- 2. The Tenants shall pay to the Landlord \$9,746.10. This amount includes rent arrears owing up to the date the Tenants moved out of the rental unit and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit is deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
- 3. If the Tenants do not pay the Landlord the full amount owing on or before February 12, 2023, the Tenants will start to owe interest. This will be simple interest calculated from February 13, 2023 at 5.00% annually on the balance outstanding.
