**Residential Tenancies Act, 2006**

Hastings Local Housing Corp. (the 'Landlord') applied for an order to terminate the tenancy and evict Starr Fortin (the 'Tenant') and for an order to have the Tenant pay the rent the Tenant owes because the Tenant failed to meet a condition specified in the order issued by the Board on August 4, 2021 with respect to application TEL-16868-21.

**Determinations:**

1. The order provided that the Landlord could apply to the Board under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant did not meet certain condition(s) specified in the order.
2. I find that the Tenant has not met the following conditions specified in the order: the Tenant did not pay \$108.00 on or before August 20, 2021, nor did they pay the lawful rent for September on or before September 1, 2021.
3. The previous application included a request for an order for the payment of arrears of rent. The resulting order required the Tenant to pay rent or some or all of the arrears of rent. Accordingly, in addition to eviction, the Landlord is entitled to request an order for the payment of arrears of rent and compensation.
4. The Tenant was ordered to pay \$864.00 for rent arrears in Order TEL-16868-21. The amount that is still owing from that order is \$864.00 and that amount is included in this order. As a result, the previous order TEL-16868-21 is cancelled.
5. Since the date of the order, the Tenant has failed to pay the full rent that became owing for the period from September 1, 2021 to September 30, 2021.

**It is ordered that:**

1. The previous order TEL-16868-21 is cancelled.

2. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before September 28, 2021.
3. The Tenant shall pay to the Landlord \$972.43\*. This amount represents the rent owing up to September 17, 2021.
4. The Tenant shall also pay to the Landlord \$6.38 per day for compensation for the use of the unit starting September 18, 2021 to the date the Tenant moves out of the unit.
5. If the Tenant does not pay the Landlord the full amount owing\* on or before September 28, 2021, the Tenant will start to owe interest. This will be simple interest calculated from September 29, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before September 28, 2021, then starting September 29, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after September 29, 2021.
