Jerome Rhoden Tenant

On October 25, 2021, Qiuyue Chen (the 'Landlord') applied for an order to terminate the tenancy and evict Jerome Rhoden (the 'Tenant') and for an order to have the Tenant pay the rent the Tenant owes because the Tenant failed to meet a condition specified in the order issued by the Board on December 3, 2020 with respect to application HOL-07792-20.

**Determinations:**

1. The order provided that the Landlord could apply to the Board under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant did not meet certain condition(s) specified in the order.
2. I find that the Tenant has not met the following conditions specified in the order:  
  
**The Tenant failed to pay to the Landlord the lawful rent on or before October 1, 2021.**  
  
**The Tenant also failed to pay to the Landlord \$1,000.00 on or before October 15, 2021 towards arrears of rent.**
3. The previous application included a request for an order for the payment of arrears of rent. The resulting order required the Tenant to pay rent or some or all of the arrears of rent. Accordingly, in addition to eviction, the Landlord is entitled to request an order for the payment of arrears of rent and compensation.
4. The Tenant was ordered to pay \$13,186.00 for rent arrears in Order HOL-07792-20. The amount that is still owing from that order is \$11,186.00 and that amount is included in this order. As a result, the previous order HOL-07792-20 is cancelled.
5. Since the date of the order, the Tenant has failed to pay the full rent that became owing for the period from August 1, 2021 to October 31, 2021.
6. The Landlord collected a rent deposit of \$2,600.00 from the Tenant and this deposit is still being held by the Landlord.

7. Interest on the rent deposit is owing to the Tenant for the period from January 29, 2019 to December 1, 2021.

**It is ordered that:**

1. Order HOL-07792-20 is cancelled.
2. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before December 12, 2021.
3. The Tenant shall pay to the Landlord \$11,324.02\*. This amount represents the rent owing up to October 31, 2021, less the rent deposit and interest the Landlord owes on the rent deposit.
4. The Tenant shall also pay to the Landlord \$85.48 per day for compensation for the use of the unit starting November 1, 2021 to the date the Tenant moves out of the unit.
5. If the Tenant does not pay the Landlord the full amount owing\* on or before December 12, 2021, the Tenant will start to owe interest. This will be simple interest calculated from December 13, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before December 12, 2021, then starting December 13, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after December 13, 2021.
