Boardwalk General Partnership (the 'Landlord') applied for an order to terminate the tenancy and evict Michael Dawson (the 'Tenant') and for an order to have the Tenant pay the rent he owes because the Tenant failed to meet a condition specified in the order issued by the Board on May 28, 2021 with respect to application SWL-47378-20.

Determinations:

1. The order provided that the Landlord could apply to the Board under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant did not meet certain condition(s) specified in the order.
2. I find that the Tenant has not met the following conditions specified in the order: the Tenant did not pay \$760.00 on or before August 15, 2021, nor did they pay the lawful rent for September on or before September 1, 2021.
3. The previous application included a request for an order for the payment of arrears of rent. The resulting order required the Tenant to pay rent or some or all of the arrears of rent. Accordingly, in addition to eviction, the Landlord is entitled to request an order for the payment of arrears of rent and compensation.
4. The Tenant was ordered to pay \$7,600.00 for rent arrears and the costs related to the Landlord's application fee in Order SWL-47378-20. The amount that is still owing from that order is \$6,077.00 and that amount is included in this order. As a result, the previous order SWL-47378-20 is cancelled.
5. Since the date of the order, the Tenant has failed to pay the full rent that became owing for the period from September 1, 2021 to September 30, 2021.
6. The Landlord collected a rent deposit of \$1,299.00 from the Tenant and this deposit is still being held by the Landlord.

7. Interest on the rent deposit is owing to the Tenant for the period from May 1, 2020 to September 17, 2021.

It is ordered that:

1. The previous order SWL-47378-20 is cancelled.
2. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before September 28, 2021.
3. The Tenant shall pay to the Landlord \$5,502.21*. This amount represents the rent owing up to September 17, 2021 and the costs related to the application fee for the previous application, less the rent deposit and interest the Landlord owes on the rent deposit.
4. The Tenant shall also pay to the Landlord \$42.71 per day for compensation for the use of the unit starting September 18, 2021 to the date the Tenant moves out of the unit.
5. If the Tenant does not pay the Landlord the full amount owing* on or before September 28, 2021, the Tenant will start to owe interest. This will be simple interest calculated from September 29, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before September 28, 2021, then starting September 29, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after September 29, 2021.
