



Order under Section 69  
**Residential Tenancies Act, 2006**

**In the matter of:** 3, 16 COACHWOOD ROAD

**Between:** Kevin McHardy Landlord

**and**

Corey Conway Tenant

Kevin McHardy (the 'Landlord') applied for an order to terminate the tenancy and evict Corey Conway (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard via videoconference on June 1, 2021.

The Landlord's legal representative, Wenda Allicock, attended the hearing. As of 1:54p.m., the Tenant was not present or represented before the Board although properly served with a notice of this hearing.

**Determinations:**

1. The Tenant has not paid the total rent the Tenant was required to pay for the period from November 1, 2020 to June 30, 2021. Because of the arrears, the Landlord served a Notice of Termination effective November 16, 2020.
2. The monthly rent is \$797.16.
3. The Tenant is in possession of the rental unit.
4. The Tenant paid \$3,834.00 after the application was filed.
5. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'). The Landlord reached out to the Tenant and offered a repayment plan. The Landlord also offered the Tenant money to move if he could not continue with the tenancy. The Tenant has been behind on his payments. The Tenant did not appear before the Board to explain his position. As such, I find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act.

**It is ordered that:**

1. Unless the Tenant voids the order as set out below, the tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before June 19, 2021.
2. The Tenant shall pay to the Landlord \$1,232.17\*, which represents the amount of rent owing and compensation up to June 8, 2021.
3. The Tenant shall also pay to the Landlord \$26.21 per day for compensation for the use of the unit starting June 9, 2021 to the date the Tenant moves out of the unit.
4. The Tenant shall also pay to the Landlord \$186.00 for the cost of filing the application.
5. If the Tenant does not pay the Landlord the full amount owing\* on or before June 19, 2021, the Tenant will start to owe interest. This will be simple interest calculated from June 20, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before June 19, 2021, then starting June 20, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord, on or after June 20, 2021.
8. If, on or before June 19, 2021, the Tenant pays the amount of \$2,029.28\*\* to the Landlord or to the Board in trust, this order for eviction will be void. This means that the tenancy would not be terminated, and the Tenant could remain in the unit. If this payment is not made in full and on time, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. The Tenant may make a motion to the Board under subsection 74(11) of the Act to set aside this order if they pay the amount required under that subsection on or after June 20, 2021 but before the Sheriff gives vacant possession to the Landlord. The Tenant is only entitled to make this motion once during the period of the tenancy agreement with the Landlord.
10. This order terminates the tenancy and permits the Landlord to file the order with Court Enforcement Office (Sheriff) to evict the Tenant. However, as of the date this matter was heard, the Sheriff cannot enforce this order as a result of Ontario Regulation 266/21 made under the Emergency Management and Civil Protection Act on April 8, 2021. The Tenant cannot be evicted from the rental unit while this regulation is in force. Eviction by the Sheriff may occur after the regulation is removed by the Ontario Government.
