



Order under Section 69
Residential Tenancies Act, 2006

Jody Meyers Tenant

Aldo Guzzo-Foliaro (the 'Landlord') applied for an order to terminate the tenancy and evict Jody Meyers (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on September 23, 2021. The Landlord's Legal Representative, Nathan Chevalier, attended the hearing. The Tenant attended the hearing.

Determinations:

1. The Tenant has not paid the total rent the Tenant was required to pay for the period from May 1, 2021 to September 30, 2021. Because of the arrears, the Landlord served a Notice of Termination effective June 28, 2021.
2. The Tenant is in possession of the rental unit.
3. The lawful monthly rent is \$\$700.00
4. The Tenant made no payments after the application was filed.
5. There is no last month's rent deposit.
6. I have considered all of the disclosed circumstances in accordance with subsection 83 of the *Residential Tenancies Act, 2006* (RTA), including the impact of COVID-19 on the parties and whether the Landlord attempted to negotiate a repayment agreement with the Tenant and find that it would not be unfair to postpone the eviction until October 31, 2021 pursuant to subsection 83(1)(b) of the Act.

It is ordered that:

1. Unless the Tenant voids the order as set out below, the tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before **October 31, 2021**.
2. The Tenant shall pay to the Landlord **\$3,068.39***, which represents the amount of rent owing and compensation up to October 7, 2021.
3. The Tenant shall also pay to the Landlord **\$23.01** per day for compensation for the use of the unit starting October 8, 2021 to the date the Tenant moves out of the unit.
4. The Tenant shall also pay to the Landlord **\$186.00** for the cost of filing the application.
5. If the Tenant does not pay the Landlord the full amount owing* on or before October 31, 2021, the Tenant will start to owe interest. This will be simple interest calculated from November 1, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before October 31, 2021, then starting November 1, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord, on or after November 1, 2021.
8. If, on or before October 31, 2021, the Tenant pays the amount of **\$3,786.00**** to the Landlord or to the Board in trust, this order for eviction will be void. This means that the tenancy would not be terminated, and the Tenant could remain in the unit. If this payment is not made in full and on time, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. The Tenant may make a motion to the Board under subsection 74(11) of the Act to set aside this order if the Tenant pays the amount required under that subsection on or after November 1, 2021 but before the Sheriff gives vacant possession to the Landlord. The Tenant is only entitled to make this motion once during the period of the tenancy agreement with the Landlord.
