CLV Group Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Cardinal Watts (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by video conference on November 16, 2021.

Only the Landlord's Legal Representative, Julie Lloyd, attended the hearing. As of 10:17 a.m. the Tenant was not present or represented at the hearing although properly served with notice of this hearing by the Board.

Determinations:

1. The Tenant has not paid the total rent the Tenant was required to pay for the period from July 1, 2021 to November 30, 2021. Because of the arrears, the Landlord served a Notice of Termination effective July 27, 2021.
2. The Tenant is in possession of the rental unit.
3. The lawful monthly rent is \$618.43.
4. The Tenant paid \$1,354.62 after the application was filed.
5. The Landlord collected a rent deposit of \$471.08 from the Tenant and this deposit is still being held by the Landlord.
6. Interest on the rent deposit is owing to the Tenant for the period from November 20, 2008 to December 31, 2020.
7. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), and find that it would not be unfair to postpone the eviction until December 31, 2021 pursuant to subsection 83(1)(b) of the Act.

It is ordered that:

1. Unless the Tenant voids the order as set out below, the tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before **December 31, 2021**.
2. The Tenant shall pay to the Landlord **\$1,059.28***, which represents the amount of rent owing and compensation up to November 24, 2021, less the rent deposit and interest the Landlord owes on the rent deposit.
3. The Tenant shall also pay to the Landlord **\$20.33** per day for compensation for the use of the unit starting November 25, 2021 to the date the Tenant moves out of the unit.
4. The Tenant shall also pay to the Landlord **\$186.00** for the cost of filing the application.
5. If the Tenant does not pay the Landlord the full amount owing* on or before December 31, 2021, the Tenant will start to owe interest. This will be simple interest calculated from January 1, 2022 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before December 31, 2021, then starting January 1, 2022, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord, on or after January 1, 2022.
8. If the Tenant wishes to void this order and continue the tenancy, the Tenant must pay to the Landlord or to the Board in trust:
 - i) **\$1,923.53** if the payment is made on or before November 30, 2021, or
 - ii) **\$2,541.96** if the payment is made on or before December 31, 2021**.If the Tenant does not make full payment in accordance with this paragraph and by the appropriate deadline, then the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. The Tenant may make a motion to the Board under subsection 74(11) of the Act to set aside this order if the Tenant pays the amount required under that subsection on or after January 1, 2022 but before the Sheriff gives vacant possession to the Landlord. The Tenant is only entitled to make this motion once during the period of the tenancy agreement with the Landlord.
