N.H.D. Developments Limited (the 'Landlord') applied for an order to terminate the tenancy and evict Amanda Best (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard via video conference on June 14, 2021. Only the Landlord's Representative, Nicole Afolabi supervised by Kenia Afolabi attended the hearing. As of 11:00 a.m., the Tenant was not present or represented at the hearing although properly served with notice of this hearing.

**Determinations:**

1. The Tenant has not paid the total rent the Tenant was required to pay for the period from August 1, 2020 to June 30, 2021. Because of the arrears, the Landlord served a Notice of Termination effective November 11, 2020.
2. The Tenant is in possession of the rental unit.
3. The lawful monthly rent increased to \$1,314.50 effective December 1, 2021.
4. The Landlord collected a rent deposit of \$1,297.44 from the Tenant and this deposit is still being held by the Landlord.
5. Interest on the rent deposit is owing to the Tenant for the period from January 1, 2020 to November 11, 2020.
6. The Tenant paid \$2,500.00 after the application was filed.
7. The arrears and costs owing to June 30, 2021 total \$11,308.50.
8. I have considered all of the disclosed circumstances in accordance with subsection 83 of the *Residential Tenancies Act, 2006* (RTA), including the impact of COVID-19 on the parties and whether the Landlord attempted to negotiate a repayment agreement with the

Tenant, and find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act.

**It is ordered that:**

1. Unless the Tenant voids the order as set out below, the tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before July 2, 2021.
2. The Tenant shall pay to the Landlord \$10,638.67 \*, which represents the amount of rent owing and compensation up to June 21, 2021, less the rent deposit and interest the Landlord owes on the rent deposit.
3. The Tenant shall also pay to the Landlord \$43.22 per day for compensation for the use of the unit starting June 22, 2021 to the date the Tenant moves out of the unit.
4. The Tenant shall also pay to the Landlord \$186.00 for the cost of filing the application.
5. If the Tenant does not pay the Landlord the full amount owing\* on or before July 2, 2021, the Tenant will start to owe interest. This will be simple interest calculated from July 3, 2021 at 2.00% annually on the balance outstanding.
6. If the unit is not vacated on or before July 2, 2021, then starting July 3, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord, on or after July 3, 2021.
8. **If the Tenant wishes to void this order and continue the tenancy, the Tenant must pay to the Landlord or to the Board in trust:**
  - i) **\$11,308.50 if the payment is made on or before June 30, 2021, or**
  - ii) **\$12,623.00 if the payment is made on or before July 2, 2021\*\*.****If the Tenant does not make full payment in accordance with this paragraph and by the appropriate deadline, then the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.**
9. The Tenant may make a motion to the Board under subsection 74(11) of the Act to set aside this order if they pay the amount required under that subsection on or after July 3, 2021 but before the Sheriff gives vacant possession to the Landlord. The Tenant is only entitled to make this motion once during the period of the tenancy agreement with the Landlord.
