

Order under Section 69 Residential Tenancies Act, 2006

Franck Hermann and Ayos Global Force Corp (the 'Landlord') applied for an order to terminate the tenancy and evict Nikolett Lakatos and Alex Matta (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on November 21, 2023.

Only the Landlord's Legal Representative Jaqueline Colley attended the hearing.

As of 9:38 am, the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlords' evidence.

Determinations:

- The Landlords served the Tenants with a valid Notice to End Tenancy Early for Nonpayment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
- 2. As of the hearing date, the Tenants were still in possession of the rental unit.
- 3. The lawful rent is \$1,100.00. It is due on the 1st day of each month.
- 4. Based on the Monthly rent, the daily rent/compensation is \$36.16. This amount is calculated as follows: \$1,100.00 x 12, divided by 365 days.
- 5. The Tenants have paid \$10,256.00 to the Landlords since the application was filed.
- 6. The rent arrears owing to November 30, 2023 are \$3,034.00.
- 7. The Landlords incurred costs of \$201.00 for filing the application and is entitled to reimbursement of those costs.

- 8. The Landlords collected a rent deposit of \$1,100.00 from the Tenants and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
- 9. Interest on the rent deposit, in the amount of \$35.56 is owing to the Tenants for the period from March 1, 2022 to November 21, 2023.
- 10. Due to the Board's order issuance policies, eviction is postponed to January 3, 2024.
- 11.1 have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), and find that it would not be unfair to postpone the eviction until January 3, 2024 pursuant to subsection 83(1)(b) of the Act.

It is ordered that:

- 1. The tenancy between the Landlords and the Tenants is terminated unless the Tenants void this order.
- 2. The Tenants may void this order and continue the tenancy by paying to the Landlords:
 - \$4,335.00 if the payment is made on or before December 31, 2023. See Schedule 1 for the calculation of the amount owing.

OR

- \$5,435.00 if the payment is made on or before January 3, 2024. See Schedule 1 for the calculation of the amount owing.
- 3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after January 3, 2024 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
- 4. If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before January 3, 2024.
- 5. If the Tenants do not void the order, the Tenants shall pay to the Landlords \$. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlords owe on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
- 6. The Tenants shall also pay the Landlords compensation of \$36.16 per day for the use of the unit starting November 22, 2023 until the date the Tenants move out of the unit.
- 7. If the Tenants do not pay the Landlords the full amount owing on or before December 22, 2023, the Tenants will start to owe interest. This will be simple interest calculated from December 23, 2023 at 7.00% annually on the balance outstanding.
- 8. If the unit is not vacated on or before January 3, 2024, then starting January 4, 2024, the Landlords may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlords on or after January 4, 2024.
