



Order under Section 69 Residential Tenancies Act, 2006

Starlight Blackstar OPCO 2 ULC (the 'Landlord') applied for an order to terminate the tenancy and evict Sivabalanadan Konesh and Niranjani Vianarasa (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on August 15, 2023.

The Landlord's representative K. Hernandez and the Tenant attended the hearing.

Determinations:

1. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenant was still in possession of the rental unit.
3. The lawful rent is \$1,241.68. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$40.82. This amount is calculated as follows: $\$1,241.68 \times 12$, divided by 365 days.
5. The Tenant has paid \$10,157.47 to the Landlord since the application was filed.
6. The rent arrears owing to August 31, 2023 are \$6,986.87.
7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$1,210.23 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.

9. Interest on the rent deposit, in the amount of \$18.82 is owing to the Tenant for the period from January 1, 2023 to August 15, 2023.

Section 83

10. Section 83 requires that I consider all the circumstances, including the Tenant's and the Landlord's situations to determine if it would be appropriate to grant section 83 relief from eviction.
11. The Tenants are long term tenants and have two children. The Tenants seek to remain at the rental unit and indicated the rent arrears accrued as a result of a loss of employment. Sivabalanadan Konesh (SK) indicated the total family income is now \$1400/bi-weekly. The Tenants proposed to pay back the arrears at a rate of \$200/month.
12. The Landlord's representative indicated the Landlord has reached out to the Tenant for a repayment plan without success. The Landlord's representative also noted the arrears are substantial and the Tenants' proposed repayment plan is unreasonable.
13. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), including the Tenant's personal and financial circumstances and balanced this with any potential prejudice to the Landlord. In the circumstances, the quantum arrears and the Tenants' current income suggests an inability to comply with a reasonable repayment plan moving forward. Notwithstanding the foregoing, I find that it would not be unfair to postpone the eviction until November 15, 2023 pursuant to subsection 83(1)(b) of the Act. The delayed eviction will provide the Tenants with additional time to either void the order as noted in my order below, or alternatively, find alternative accommodations.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$8,414.55 if the payment is made on or before September 30, 2023. See Schedule 1 for the calculation of the amount owing.

OR

 - \$9,656.23 if the payment is made on or before October 31, 2023. See Schedule 1 for the calculation of the amount owing.

OR

 - \$10,897.91 if the payment is made on or before November 15, 2023. See Schedule 1 for the calculation of the amount owing.

1. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after November 15, 2023 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
2. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before November 15, 2023**
3. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$5,314.44. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
4. The Tenant shall also pay the Landlord compensation of \$40.82 per day for the use of the unit starting August 16, 2023 until the date the Tenant moves out of the unit.
5. If the Tenant does not pay the Landlord the full amount owing on or before October 9, 2023, the Tenant will start to owe interest. This will be simple interest calculated from October 10, 2023 at 6.00% annually on the balance outstanding.
6. If the unit is not vacated on or before November 15, 2023, then starting November 16, 2023, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after November 16, 2023.
