



**Order under Section 69  
Residential Tenancies Act, 2006**

MEDALLION CORPORATION (the 'Landlord') applied for an order to terminate the tenancy and evict Angel Angel and Anmol Bedi (the 'Tenants') because the Tenants did not pay the rent that the Tenants owes.

This application was heard by videoconference on August 16, 2023. The Landlord was represented at the hearing by Marja Jelic. The Tenants was not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlord's evidence.

**Determinations:**

1. The Landlord served the Tenants with a valid Notice to End Tenancy Early for Nonpayment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenants were still in possession of the rental unit.
3. The lawful rent is \$1,239.01. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$40.73. This amount is calculated as follows: \$1,239.01 x 12, divided by 365 days.
5. The Tenants has paid \$6,044.00 to the Landlord since the application was filed.

6. The rent arrears owing to August 31, 2023, are \$197.39.
7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$1,195.00 from the Tenants and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
9. Interest on the rent deposit, in the amount of \$48.06 is owing to the Tenants for the period from July 1, 2021, to August 16, 2023.
10. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), and find that it would not be unfair to postpone the eviction until September 30, 2023, pursuant to subsection 83(1)(b) of the Act.

**It is ordered that:**

1. The tenancy between the Landlord and the Tenants is terminated unless the Tenants voids this order.
  2. **The Tenants may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
    - \$383.39 if the payment is made on or before August 31, 2023. See Schedule 1 for the calculation of the amount owing.
- OR**
- \$1,622.40 if the payment is made on or before September 30, 2023. See Schedule 1 for the calculation of the amount owing.
  3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants has paid the full amount owing as ordered plus any additional rent that became due after September 30, 2023, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
  4. **If the Tenants does not pay the amount required to void this order the Tenants must move out of the rental unit on or before September 30, 2023**
  5. As of the date of the hearing, the amount of the rent deposit and interest the Landlord owes on the rent deposit exceeds the arrears of rent, compensation and the cost of filing the application the Landlord is entitled to by \$1,447.00. See Schedule 1 for the calculation of the amount owing. However, the Landlord is authorized to deduct from the amount owing to the Tenants \$40.73 per day for compensation for the use of the unit starting August 17, 2023, until the date the Tenants moves out of the unit.

6. The Landlord or the Tenants shall pay to the other any sum of money that is owed as a result of this order.
7. If the unit is not vacated on or before September 30, 2023, then starting October 1, 2023, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
8. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after October 1, 2023.
