



**Order under Section 69  
Residential Tenancies Act, 2006**

Balbir Jandu and Manjeet Jandu (the 'Landlords') applied for an order to terminate the tenancy and evict Emma Hunter and Bryon Legoult (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on July 20, 2023.

Only the Landlords' legal representative Andrea Lahey and the Landlord, Balbir Jandu attended the hearing.

As of 1:54p.m., the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlords' evidence.

**Determinations:**

1. The Landlords served the Tenants with a valid Notice to End Tenancy Early for Nonpayment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenants were still in possession of the rental unit.
3. The lawful rent is \$2,800.00. It is due on the 1st day of each month.

4. Based on the Monthly rent, the daily rent/compensation is \$92.05. This amount is calculated as follows: \$2,800.00 x 12, divided by 365 days.
5. The Tenants have not made any payments since the application was filed.
6. The Landlords collected a \$500.00 security deposit from the Tenants and this deposit is still being held by the Landlords. This is prohibited under s.134 of the Residential Tenancies Act, 2006 (the 'Act'). Therefore, the Tenants will be credited this amount.
7. The rent arrears owing to July 31, 2023, are \$15,900.00. This amount is calculated as follows: Rent arrears till July 31, 2023, of \$16,400.00 less \$500.00 credit = \$15,900.00.
8. The Landlords incurred costs of \$186.00 for filing the application and are entitled to reimbursement of those costs.
9. The Landlords collected a rent deposit of \$2,800.00 from the Tenants and this deposit is still being held by the Landlords. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
10. Interest on the rent deposit, in the amount of \$78.28 is owing to the Tenants for the period from November 30, 2021, to July 20, 2023.
11. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the Act, including the impact of COVID-19 on the parties and whether the Landlords attempted to negotiate a repayment agreement with the Tenants and find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act. The Landlords' legal representative is not aware of any circumstances which the Board should be made aware of whether to refuse or delay the eviction.

It is ordered that:

1. The tenancy between the Landlords and the Tenants is terminated unless the Tenants void this order.
2. The Tenants may void this order and continue the tenancy by paying to the Landlords or to the LTB in trust:
  - \$18,886.00 if the payment is made on or before August 20, 2023. See Schedule 1 for the calculation of the amount owing.
3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after August 20, 2023 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
4. If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before August 20, 2023
5. If the Tenants do not void the order, the Tenants shall pay to the Landlords \$12,248.72. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlords owe on the rent deposit are

deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.

6. The Tenants shall also pay the Landlords compensation of \$92.05 per day for the use of the unit starting July 21, 2023, until the date the Tenants move out of the unit.
7. If the Tenants do not pay the Landlords the full amount owing on or before August 20, 2023, the Tenants will start to owe interest. This will be simple interest calculated from August 21, 2023, at 6.00% annually on the balance outstanding.
8. If the unit is not vacated on or before August 20, 2023, then starting August 21, 2023, the Landlords may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlords on or after August 21, 2023.
