



## **Order under Section 78(6) Residential Tenancies Act, 2006**

Sireg Management Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Brittany Wilson, Michael Teixeira and Zachary Wilson (the 'Tenants') and for an order to have the Tenants pay the rent they owe because the Tenants did not meet a condition specified in the order issued by the LTB on with respect to application LTB-L-022533-22.

This application was heard on April 26, 2023. The Landlord's representative Elena Jacob, and the Tenants, represented by Linda Tranter, attended the hearing.

At the hearing the parties consented to the following order.

The parties agree the Tenants owe the Landlord \$8,672.25 in arrears and costs to the end of April 2023.

**It is ordered that:**

1. Order LTB-L-012565-23 is set aside.
2. Order LTB-L-022533-22 is cancelled and replaced with the following:
3. The Tenants shall pay to the Landlord \$8,672.25 as follows:
  - The Tenants shall pay to the Landlord \$4,000.00 on or before May 10, 2023.
  - The Tenant shall pay to the Landlord \$400.00 on or before the 20<sup>th</sup> day of each consecutive month commencing May 2023 and continuing through March 2024.
  - The Tenants shall pay to the Landlord \$272.25 on or before April 20, 2024.

4. The Tenants shall also pay to the Landlord the lawful rent in full and on time for each consecutive month commencing May 2023 and continuing through April 2024.
5. In the event the Tenants fail to make the above said payment in full and on time, the entire balance of the amount set out in this Order will become due and payable forthwith under this Order. The Landlord shall be entitled to apply to the Board, no later than 30 days after a breach of this Order, without notice to the Tenants, for an Order terminating the tenancy and evicting the Tenants and for any arrears that become due after the date of this order, pursuant to Section 78 of the Residential Tenancies Act, 2006.
