



**Order under Section 69
Residential Tenancies Act, 2006**

Antonina Kotorobai (the 'Landlord') applied for an order to terminate the tenancy and evict Luis Bautista (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes. The Landlord also applied for an order to terminate the tenancy and evict the Tenant for persistent late payment of rent.

This application was heard by videoconference on January 9, 2023.

Only the Landlord's representative, J. Lambe, attended the hearing

As of 9:44 am the Tenant was not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlord's evidence.

Determinations:

1. The Landlord's representative indicated at the outset of the hearing that the Tenant had vacated the unit as of July 1, 2022. The Landlord no longer sought termination of the tenancy but sought an order for payment of rent owing.
2. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
3. The Tenant was in possession of the rental unit on the date the application was filed.
4. The Tenant vacated the rental unit on July 1 2022.. Rent arrears are calculated up to the June 30, 2022.
5. The lawful rent is \$3,500.00. It was due on the 1st day of each month.
6. The Tenant has not made any payments since the application was filed.
7. The rent arrears owing to June 30, 2022 are \$21,000.00.

8. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
9. The Landlord collected a rent deposit of \$3,500.00 from the Tenant and this deposit is still being held by the Landlord. The rent deposit is applied to the arrears of rent because the tenancy terminated.
10. Interest on the rent deposit, in the amount of \$27.85 is owing to the Tenant for the period from November 1, 2021 to June 30, 2022.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated as of July 1, 2022, the date the Tenant moved out of the rental unit
2. The Tenant shall pay to the Landlord \$17,658.15. This amount includes rent arrears owing up to June 30, 2022 and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit is deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
3. If the Tenant does not pay the Landlord the full amount owing on or before January 23, 2023, the Tenant will start to owe interest. This will be simple interest calculated from January 24, 2023 at 5.00% annually on the balance outstanding.
