



Order under Section 69 Residential Tenancies Act, 2006

TORONTO COMMUNITY HOUSING CORP (the 'Landlord') applied for an order to terminate the tenancy and evict Ronnette Archibald (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled to be heard by videoconference on October 26, 2022.

The Landlord was represented by Landlord Agent, Dale Maingot.

The Tenant was self-represented and spoke with Tenant Duty Counsel prior to the mediation.

The parties agree:

1. The lawful rent is \$1,492.00 and is due on the 1st day of each month.
2. Based on the monthly rent, the daily compensation is \$49.05. This amount is calculated as follows: \$1,492.00 multiplied by 12 months, divided by 365 days.
3. The Tenant has not made any payments since the application was filed.
4. The rent arrears owing to October 31, 2022 are \$14,780.00.
5. The rent owing to November 30, 2022 is \$16,272.00.
6. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
7. There is no last month's rent deposit.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.

2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$14,966.00 if the payment is made on or before October 31, 2022. See Schedule 1 for the calculation of the amount owing.
 - \$16,458.00 if the payment is made on or before November 26, 2022. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after November 26, 2022 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before November 26, 2022.**
5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$14,749.30. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. See Schedule 1 for the calculation of the amount owing.
6. The Tenant shall also pay the Landlord compensation of \$49.05 per day for the use of the unit starting October 27, 2022 until the date the Tenant moves out of the unit.
7. If the Tenant does not pay the Landlord the full amount owing on or before November 26, 2022, the Tenant will start to owe interest. This will be simple interest calculated from November 27, 2022 at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before November 26, 2022, then starting November 27, 2022, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after November 27, 2022.

C. Amount the Tenant must pay if the tenancy is terminated

Plus daily compensation owing for each day of occupation starting October 27, 2022	\$49.05 (per day)
