



**Order under Subsection 87(1)
Residential Tenancies Act, 2006**

SKYLINE LIVING (the 'Landlord') applied for an order requiring GAVEN SEMCHISON-BURKE and SHELBY MULIKOW (the 'Tenants') to pay the rent that the Tenants owe.

This application was heard by videoconference on October 26, 2022.

Only the Landlord's Legal Representative Terry Medeiros attended the hearing.

As of 2:30 p.m., the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. Since the Tenants did not attend and the Landlord was prepared to proceed, the matter proceeded by way of an uncontested hearing pursuant to section 7 of the *Statutory Powers Procedure Act*, R.S.O. 1990.

Determinations:

1. At the hearing the Landlord's Legal Representative relied on oral submissions and referred to documents to support their application.
2. Based on the uncontested evidence of the Landlord's Legal Representative I find the Tenants vacated the rental unit on June 30, 2022. The Tenants were in possession of the rental unit on the date the application was filed.
3. The Tenants did not pay the total rent they were required to pay for the period from May 1, 2022 to June 30, 2022.
4. The lawful rent was \$1,296.36. It was due on the 1st day of each month.
5. The Tenants have paid \$326.45 to the Landlord after the application was filed.
6. The rent arrears owing to June 30, 2022 are \$2,139.68.

7. The Landlord collected a rent deposit of \$1,322.81 from the Tenants and this deposit is still being held by the Landlord. The rent deposit is applied to the arrears of rent because the tenancy is terminated.
8. The Landlord incurred costs of \$201.00 for filing the application and is entitled to reimbursement of those costs.

It is ordered that:

1. The tenancy is terminated effective June 30, 2022.
2. The Tenants shall pay to the Landlord \$1,017.87*. This amount includes rent arrears owing up to June 30, 2022 and the cost of the application minus the rent deposit.
3. If the Tenants do not pay the Landlord the full amount owing on or before November 28, 2022, the Tenants will start to owe interest. This will be simple interest calculated from November 29, 2022 at 4.00% annually on the balance outstanding.
