



Order under Section 69 Residential Tenancies Act, 2006

Qiuju Wu and Shufu Li (the 'Landlords') applied for an order to terminate the tenancy and evict Fikirte Mechal Gebremariam and Ruth Nkrumah-Asiamah (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on September 29, 2022.

Only the Landlords' Legal Representative, Yun Tao Li attended the hearing.

As of 2:22 pm, the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlords' evidence.

Determinations:

1. The Landlords served the Tenants with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenants were still in possession of the rental unit.
3. The lawful rent is \$2,400.00. It is due on the 8th day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$78.90. This amount is calculated as follows: \$2,400.00 x 12, divided by 365 days.
5. The Tenants have not made any payments since the application was filed.
6. The rent arrears owing to October 7, 2022 are \$23,800.00.
7. The Landlords incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

8. The Landlords collected a rent deposit of \$2,400.00 from the Tenants and this deposit is still being held by the Landlords. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
9. Interest on the rent deposit, in the amount of \$78.52 is owing to the Tenants for the period from November 8, 2019 to September 29, 2022.
10. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), including the impact of COVID-19 on the parties and whether the Landlords attempted to negotiate a repayment agreement with the Tenants and find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act.

It is ordered that:

11. The tenancy between the Landlords and the Tenants is terminated unless the Tenants void this order.
12. **The Tenants may void this order and continue the tenancy by paying to the Landlords:**
 1. \$26,386.00 if the payment is made on or before November 7, 2022. See Schedule 1 for the calculation of the amount owing.

OR

 2. \$28,786.00 if the payment is made on or before November 8, 2022. See Schedule 1 for the calculation of the amount owing.
13. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after November 8, 2022 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
14. **If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before November 8, 2022.**
15. If the Tenants do not void the order, the Tenants shall pay to the Landlords \$20,843.28. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlords owe on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
16. The Tenants shall also pay the Landlords compensation of \$78.90 per day for the use of the unit starting September 30, 2022 until the date the Tenants move out of the unit.
17. If the Tenants do not pay the Landlords the full amount owing on or before November 8, 2022, the Tenants will start to owe interest. This will be simple interest calculated from November 9, 2022 at 4.00% annually on the balance outstanding.

18. If the unit is not vacated on or before November 8, 2022, then starting November 9, 2022, the Landlords may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
19. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlords on or after November 9, 2022.

Total the Tenants must pay to continue the tenancy	\$28,786.00

C. Amount the Tenants must pay if the tenancy is terminated

Rent Owing To Hearing Date	\$23,135.80
Application Filing Fee	\$186.00
Less the amount of the last month's rent deposit	- \$2,400.00
Less the amount of the interest on the last month's rent deposit	- \$78.52
Total amount owing to the Landlords	\$20,843.28
Plus daily compensation owing for each day of occupation starting September 30, 2022	\$78.90 (per day)
