Chea Sook Lim and Ji Hoon Kim (the 'Landlords') applied for an order to terminate the tenancy and evict Daniel Nwakaeze and Daniel Nwakaeze (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on January 21, 2025.

Only the Landlords, and the Landlords' Representative, Ki Shik Shin, attended the hearing.

As of 1:39 p.m., the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlords' evidence.

Determinations:

- The Landlords served the Tenants with a valid Notice to End Tenancy Early for Nonpayment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
- 2. As of the hearing date, the Tenants were still in possession of the rental unit.
- 3. The lawful rent is \$2,600.00. It is due on the 15th day of each month.
- 4. Based on the Monthly rent, the daily rent/compensation is \$85.48. This amount is calculated as follows: \$2,600.00 x 12, divided by 365 days.
- 5. The Tenants have not made any payments since the application was filed.
- 6. The rent arrears owing to February 14, 2025, are \$17,500.00.
- 7. The Landlords incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

8. The Landlords collected a rent deposit of \$2,600.00 from the Tenants and this deposit is still being held by the Landlords. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.

- 9. Interest on the rent deposit, in the amount of \$50.22 is owing to the Tenants for the period from April 15, 2024, to January 21, 2025.
- 10.I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), including whether the Landlords attempted to negotiate a repayment agreement with the Tenants and find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act.

It is ordered that:

- 1. The tenancy between the Landlords and the Tenants is terminated unless the Tenants void this order.
- 2. The Tenants may void this order and continue the tenancy by paying to the Landlords or to the LTB in trust:
 - \$17,686.00 if the payment is made on or before February 14, 2025. See Schedule 1 for the calculation of the amount owing.
- 3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after February 14, 2025, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
- 4. If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before February 14, 2025.
- 5. If the Tenants do not void the order, the Tenants shall pay to the Landlords \$8,980.98. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlords owe on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
- 6. The Tenants shall also pay the Landlords compensation of \$85.48 per day for the use of the unit starting January 22, 2025, until the date the Tenants move out of the unit.
- 7. If the Tenants do not pay the Landlords the full amount owing on or before February 14, 2025, the Tenants will start to owe interest. This will be simple interest calculated from February 15, 2025, at 5.00% annually on the balance outstanding.
- 8. If the unit is not vacated on or before February 14, 2025, then starting February 15, 2025, the Landlords may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlords on or after February 15, 2025.
